

### ARTICLES OF INCORPORATION OF TOWER OF PRAYER, INC.

The undersigned incorporator, in compliance with Chapter 617, F.S., (Not for Profit) hereby adopts the following Articles of Incorporation:

#### <u>ARTICLE ONE</u>

NAME

The name of the corporation shall be Tower of Prayer, Inc.

#### **ARTICLE TWO**

#### PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be 8405 N. Himes Ave., Tampa, FL 33607.

#### **ARTICLE THREE**

#### **PURPOSE**

The corporation is hereby formed as a non-profit corporation for the purpose of organizing a church that will conduct religious services and perform religious and charitable activities benefiting the congregation and community at large.

The corporation be organized as a 501 (C) (3) charitable organization and shall operate at all times and in all respects as a 501(C) (3) charitable organization, as specified in the Internal Revenue Code. The corporation shall take all necessary actions in order to be approved as a 501(C) (3) charitable organization.

#### **ARTICLE FOUR**

#### MANNER OF ELECTION

The Board of Directors shall initially be appointed by the incorporator and will establish rules and policies for the admittance of individuals to the church as members.

There shall be no stock issued to members. Membership in the church shall be evidenced by a letter from the Board of Directors accepting and admitting a person as a member. Upon admittance to the membership, each member shall be entitled to (1) one vote for the election of Directors. Directors shall be elected annually by a simple majority vote of the membership.


