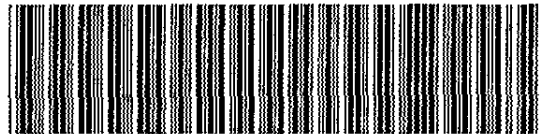

**ARTICLES OF INCORPORATION
OF
FLORIDIANS FOR FAMILY VALUES, INC.

(A Corporation Not for Profit)**

In order to form a corporation under and in accordance with the provisions of Chapter 617, Florida Statutes for the formation of corporations not for profit, we, the undersigned, do hereby associate ourselves together as a corporation for the purposes and with the powers hereinafter set forth, and to accomplish that objective we do hereby make, adopt and subscribe these Articles of Incorporation, to wit:

**I.
NAME OF CORPORATION**

The name of the Corporation shall be Floridians for Family Values, Inc.

**II.
ADDRESS OF PRINCIPAL OFFICE**

The address of the principal office of the Corporation is 203 N. Gadsden Street, Suite 2B, Tallahassee, Florida 32301, and the mailing address for the Corporation is P.O. Box 213, Tallahassee, Florida 32302.

**III.
PURPOSES**

The purposes for which the Corporation is formed are as follows:

To carry out exempt functions as defined in Section 501(c)(4), Internal Revenue Code.

The Corporation shall not engage in any business of a kind ordinarily carried on for profit and nothing in these Articles of Incorporation or in the Bylaws of the Corporation shall authorize the Corporation to, and the Corporation shall not, enter any transaction, carry on any activity, or engage in any business for pecuniary profit, and any income received by the Corporation shall be applied only to the nonprofit purposes and objectives of the Corporation set forth herein and no part thereof during membership or upon termination of membership shall inure to the benefit of any private member or individual.

**IV.
BOARD OF DIRECTORS**

The affairs of the Corporation shall be managed by a Board of Directors consisting at least 3 members. The number and election of the Directors shall be as provided in the Bylaws of the Corporation. The initial Board of Directors shall be as follows:

V.
TERM OF EXISTENCE

The term for which this Corporation shall exist shall be perpetual unless dissolved according to law.

VI.
DISPOSITION OF ASSETS UPON DISSOLUTION

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(4) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to the state or local government, for a public purpose.

VII.
MEMBERSHIP

The Corporation shall consist of general membership which may be evidence by a Certificate of Membership which shall contain the statement printed permanently on the face of the certificate that the Corporation is a non-profit corporation. The criteria for membership shall be as set forth in the Bylaws of the Corporation.

VIII.
BYLAWS

The initial Board of Directors of the Corporation shall adopt Bylaws consistent with these Articles of Incorporation. Thereafter, the Bylaws may be altered or rescinded by the directors in the manner provided by such Bylaws.

IX.
REGISTERED OFFICE

The registered office of the Corporation shall be located at 203 North Gadsden Street, suite 2B, Tallahassee, Florida 32301, and the registered agent shall be Cory Tilley.

X.
INCORPORATOR

The name and address of the incorporator of these Articles of Incorporation is Cory

AMENDMENT

The Corporation reserves the right to alter, amend or repeal any provisions contained in these Articles of Incorporation, or any amendment thereto, according to law.


