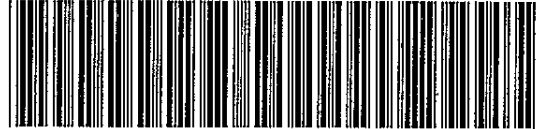

ARTICLES OF INCORPORATION
OF
THE INNOVATION COMMUNITY EMPOWERMENT CORPORATION
(A Florida Not For Profit Corporation)

The undersigned, acting as Incorporator of a corporation, adopts the following Articles of Incorporation for such corporation.

ARTICLE I
CORPORATE NAME

The name of the corporation shall be **The Innovation Community Empowerment Corporation, Inc.** The nonprofit corporation is organized for general purposes, pursuant to the Florida Corporations Not For Profit Laws as set forth in Chapter 617, Florida Statutes, and shall have perpetual existence. The corporation shall commence existence on the date these Articles are filed with the Secretary of State.

ARTICLE II
PRINCIPAL OFFICE

The location and mailing address of the principal office of the corporation is Innovation Baptist Church, 333 Ausley Road, Tallahassee, Florida 32304.

ARTICLE III
PURPOSES; POWERS

1. The purposes for which the Corporation is organized and operated are exclusively charitable and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or the corresponding provision of any future United States Internal Revenue law.

2. The Corporation's charitable and educational goals shall be met primarily by its commitment to aid, service and develop the community of Tallahassee, Florida, and surrounding areas to reach their fullest potential by providing social outreach and promoting educational success, spiritual growth and personal leadership. Additionally, the corporation will foster affordable housing and provide education and resources for first-time homeowners.

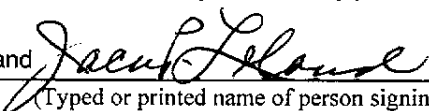
