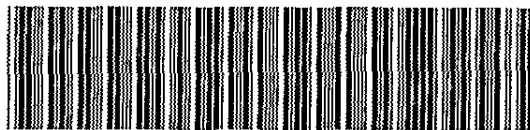

The undersigned, for the purpose of forming a Non-Profit Corporation under Florida Statutes Chapter 617, do hereby make and adapt the following proposed Articles of Incorporation.

Article I: Name

The name of this corporation shall be: The Refuge of Saint Benedict Incorporated

Article II: Principal Office

Principal place of business shall be 704 N. Chestnut Road, Lakeland, Polk County, Florida 33815.

Article III: Purpose

The Corporation is organized for the following purposes:

- A. The Corporation is organized exclusively for Charitable purposes.
- B. To offer Spiritual Ministry to all or any who request Spiritual Guidance.
- C. To reach out Domestically and in Foreign Fields doing Missionary work.
- D. To construct a Retreat Facility in Lakeland, Florida, for the main purpose of ministering to many people, families, and groups.

Article IV: Manner of Election

The manner in which the directors are appointed or elected:

The President of the governing body appoints the directors to serve on the Board. The Powers of the Corporation shall be subject to and shall be exercised in accordance with the provisions of the Bylaws.
