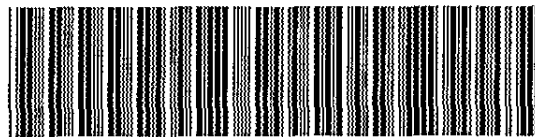

The undersigned, for the purpose of forming a not for profit corporation under Chapter 617, Florida Statutes, does hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the corporation is **PEER, INC.**

ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address of the corporation is **4013 East Fowler Avenue, Tampa, FL 33617-2622.**

ARTICLE III: PURPOSE

The pupose of this business is to provide research and education for the preservation and restoration of Florida natural resources.

ARTICLE IV: QUALIFICATION

The qualifications for members and the manner of their admission are stated in the bylaws of the corporation.
