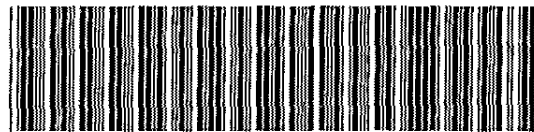

**A NON-PROFIT ORGANIZATION**

We the undersigned subscribers to these Articles of Incorporation. Each a natural person Competent to contract hereby associate ourselves together to form a corporation under the laws of the state of Florida.

**ARTICLE 1 - NAME**

The name of this corporation shall be known as **Youth With A Vision Achievement Foundation, Inc.** This corporation shall not join, belong, or pay dues to any other corporation. However, members may do so if they desire to.

**ARTICLE II - PRINCIPLE OFFICE**

The principal place of business for the corporation shall be at  
1441 NE 9 Street Homestead, Florida 33033.

**ARTICLE III - PURPOSE**

The purpose of Youth With A Vision Achievement Foundation is:

- A) To conduct activities which are exclusively charitable, literary, and educational within the meaning of section 501c3 of the Internal Revenue Code, as the same may be amended from time to time.
- B) To reach out to youth's in the community, hence, empowering and equipping them for the future to be leaders of integrity and respect.
- C) To build their self-esteem, confidence, and help point them in the right direction towards their dreams and vision for their future.
- D) To provide programs such as Computer Training, Tutoring, Community Service, Job Interview Preparation to educate our youths.

- E) To provide resources pertaining to Youth Crisis, Violence, HIV, Drugs, Drunk Driving, Sexual Abuse, and of the like.
- F) Youth With A Vision will be a place of informational resources assisting in personal needs. Such as educationally, emotionally, and spiritually.
- G) To render Wise and Godly Counseling, encouraging the children to do the right thing and to keep their focus on their future.

#### **ARTICLE IV - MANNER OF ELECTION OF DIRECTORS**

Board of Directors is a group of person vested with the administrative excellence to govern the affairs of this corporation through the guidance of the Holy Spirit and Integrity of the Word of God. All candidates who desires to abstain a position of director must meet the following prerequisites:

- A) All active supporter of Youth With A Vision Achievement Foundation organization of minimum 6 month - a year.
- B) Must have experienced working with children.
- C) Must be a person who has love, compassion, self-respect and an example in the community.
- D) Person must have a desirer to help and assist youths and reach out to them with kindness.
- E) Person who does not live a life of dishonesty, misconduct, debauchery or licentiousness behavior. Involvement in such activities disqualifies the candidate from all consideration to occupy any position or office in this organization. However, those who conduct themselves honorably, morally, and ethically shall be considered.

After all prerequisites have been met, and carefully examination of the applicants; The Board of Directors will either approve or disapprove the applicant by a 2/3 vote by way of secret ballot. The applicants will be notified within 14 days, as to the decision made.

If the approved candidates is believed and / or found guilty of treachery or bribery at any level, the CEO will reject the approved candidate and will appoint another candidate to occupy the position. Furthermore, an extensive investigation will be performed immediately by a special panel appointed by the CEO.


