# NON-PROFIT CORPORATION ARTICLES OF INCORPORATION

The undersigned acting as incorporation(s) of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

ARTICLE 1 Name
