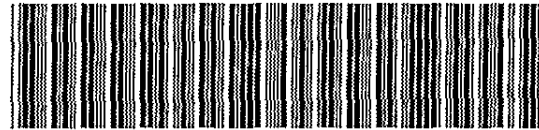

### ARTICLE III PURPOSE

Centro Cristiano de Miami, Inc. is organized exclusively for charitable religious outreach propagating the gospel of Jesus Christ. This includes providing counseling for families, youth programs, leadership training and evangelistic efforts.

These services will be offered by locally trained personnel in liaison with the United Pentecostal Church International and any other ministries approved by local church.

Said organization is organized for religious educational purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distributions of statements) and political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of this document the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code, or corresponding Section of any future tax code, or (b) by an organization, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code or corresponding Section of any future federal tax code.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning 501(c)(3) of the Internal Revenue Code or corresponding Section of any future federal tax code, or disposed of shall be disposed of by the Court of Common Pleas of the County in which the principal office of the organization is then located, exclusively for such purposes or to such organization of organizations, as said Corporation shall determine which are organized and operated exclusively for such purposes.
