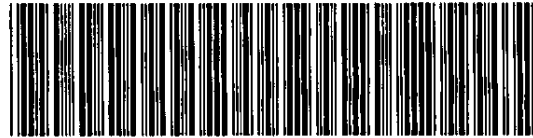

Amendment to Article VIII, Section (c), BOARD OF DIRECTORS

Complete text if OLD Article VIII, Section (c), adopted at initial formation of non-profit, March 31, 2003:

(c) The directors elected at the first annual meeting and at all times thereafter shall serve for a term of one (1) year until the next annual meeting of members following the election of directors and until the qualification of successors in office.

Annual meetings shall be held during the month of January of each year at the principal office of the corporation or at such places or places as the Board of Directors may designate from time to time by resolution.

Complete text of NEW Article VIII, Section (c) in its entirety, effective November 9, 2016:

(c) The directors elected at the first biennial meeting to be held in January, 2017, shall serve for a term of two (2) years.

Biennial meetings will be held in odd-numbered years for the purpose of electing officers at the principal office of the corporation or at such place as the Board of Directors may designate by resolution.
