**ARTICLES OF INCORPORATION

THE UNDERSIGNED, acting as sole incorporator of **RACHEL'S HOPE, INC.**, a not for profit corporation under Chapter 617 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation:

**ARTICLE I

PURPOSE

Rachel's Hope, Inc. will provide room, board, and maternity related services for pregnant teenage girls.

The Corporation is organized exclusively for educational and charitable purposes. In carrying out its purposes, the Corporation may receive, hold, invest and reinvest gifts and grants of money or property, collect income, sell property and disburse funds to any person or organization, public or private.

No part of the net earnings of this Corporation shall inure to the benefit of, or be distributable to, any member, officer or director of this Corporation or any private individual (except that reasonable compensation may be paid for services rendered to or for the Corporation affecting one or more of its purposes).

No member, director or officer of this Corporation, or any private individual, shall be entitled to share in the distribution of any of the corporate assets on dissolution of this Corporation.

ARTICLE VIII
DISSOLUTION
