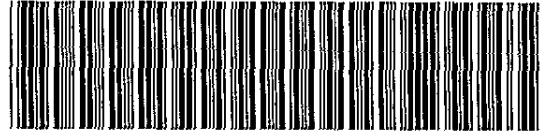



ARTICLES OF INCORPORATION
OF
HEART OF CHRIST CHRISTIAN CHURCH, INC.

The undersigned, acting as incorporator of a corporation pursuant to chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE ONE:

The name of the Corporation is HEART OF CHRIST CHRISTIAN CHURCH, INC.

ARTICLE TWO:

The principal place of business and mailing address of this corporation shall be 3202 Clewiston St., Deltona, FL 32725.

ARTICLE THREE:

The specific purpose for which the corporation is organized are to engage in any or all of the aspects of the teaching and preaching of the Gospel of Jesus Christ as set forth in the Bible, the Word of God, which shall be its only rule of faith and practice. At this time this corporation, recognizing the Bible as the Word of God and the New Testament as its full authority in matters pertaining to the conduct of the church, will declare itself to be a free and autonomous body, claiming the right to free government and recognizing no outside religious authority or control.

ARTICLE FOUR:

The method of election of directors shall be stated in the bylaws.


ARTICLE FIVE:

The name and address of the incorporator is RICHARD L. STEVENS, 3202 Clewiston St., Deltona, FL 32738.


