ARTICLES OF INCORPORATION
In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be:
Word of Life Family Church & International Missionary Fellowship, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

Word of Life Family Church & International Missionary Fellowship, Inc. is organized exclusively for religious, charitable, and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code (or the corresponding section of any future United States Internal Revenue Law) and in Compliance with Chapter 617, F.S., (Not for Profit) State of Florida, USA. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation, and the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or the corresponding provision of any future United States Internal Revenue Law, or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code or the corresponding provision of any future United States Internal Revenue Law. Word of Life Family Church and International Missionary Fellowship, Inc. shall promote fellowship and unity among believers to facilitate the work of the ministry and to propagate the Gospel of Jesus Christ through every available means both at home and abroad.

1. To preach the gospel of our Lord Jesus Christ at home and abroad;
2. To teach the Word of God with all authority and power;
3. To provide a place of true spiritual worship where Christ is honored and glorified;
4. To provide a center of training in Bible knowledge and doctrine for the whole family;
5. To encourage a program of continuous witnessing under the direction of the Holy Spirit;
6. To provide spiritual fellowship and encouragement to fellow believers in the Lord Jesus Christ;
7. To advance the teaching of the gospel of Jesus Christ our Lord and Savior, and to institute and maintain missionary education and outreach at home and abroad.
8. To give faithful commitment to all that is contained in the Inspired Word of God.
9. To accept and to participate in the Great Commission of our Lord, Jesus Christ, including distribution of food, clothing, and shelter, directly or indirectly to those that are in need (Matt 28:19-20; Mark 16:15)
10. To build, in Christ, a church of Love where believers, by working together for the unity, edification, discipline, and encouragement of others, might grow in the unity of faith (Acts 2:42; Romans 12; Colossians 3:12-15; Ephesians
11. To cause to be published and distributed periodicals, literature, books audio/video tapes and such teaching/training materials as are in harmony with the objects and purposes of the Kingdom Gospel.
12. To train, license, ordain and commission ministers of the 5-Fold Ministry (Ephesians 4:11) to establish new churches and encourage growth in existing churches by providing support services, financial and otherwise, for churches to accomplish their ministry at home and abroad.
13. To provide avenues and agencies that will give members an opportunity to grow and develop in ministry to others, through cooperative service for Christ, both inside and outside the church.

ARTICLE IV PERIOD OF DURATION

The period of duration:

The period of duration for Word of Life Family Church & International Missionary Fellowship, Inc. shall be perpetual.

ARTICLE V MANNER OF ELECTION

The manner in which the directors are elected or appointed:

The directors/officers after the term of the initial directors/officers shall be elected or appointed during the fall Bible Conference every other year.

ARTICLE VI USE OF FUNDS

The manner in which Funds of the Corporation shall be used:

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Three hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE VII DISSOLUTION OF THE CORPORATION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
