RESOLVED, that a certified copy of the original articles of the incorporation be attached hereto to the following articles of INC. such corporations be hereby adopted as the followings.

The undersigned, acting as incorporators of the Florida Non Profit corporation act, chapter 617, adopt the following articles of the incorporation for such corporation.

Article #1 1ST ASIAN ASSEMBLY OF GOD INC.

Article #2 Continuance

The corporation shall have a continuance existence. The corporation existence will commence on the filing of those articles by the Department of State.

Article #3 Object

The corporation is in order to supply of God fearing and teaching. House of Worship, send forth schools Pastor ship, and all establishing commitment with the Holiness, Educational, Good Will, and Liberal character. The members may be generally instructed. Guided concerning these articles Purity among people, Promoted local and foreign Mission to aide and spread the Gospel of Jesus To all nations

Article #4 Corporation

This organization shall be composed of Bishop, Overseer, Pastor, Minister, Deacon, Missionaries, Trustees and Members. Who is in good faith congregate in the various places assembly maintained by this

Article #5 Affairs and Management

The affairs of this corporation shall be managed by Rev. Sam Corgelas and his successor Rev. Anes Charles: DeRanot Charles.

Article #7 Duration

The duration of the corporation shall be perpetual.

Article #8 Initial Registered Office Agent

The street address of the initial principal registered Church 2690 47 Terrace SW Naples, Florida 34116-7712.

Article #9 Incorporators

The names of the residence of the subscribers of these articles of Incorporation are the same as those in article #6 above.

### Article #10 Conduct of the Corporate Affairs

The conduct of the corporate affairs will be limited as outlined in by-laws of the corporation are to be regulated as out-lined in the by-laws of the corporation. The manner in which directors are elected or appointed will be as provided in the by-laws of the corporation.

### Article #11 Bishop/Overseer

SECTION 1. The Bishop/overseer shall be Chief Apostle and spiritual advisor of the organization he shall exercise at all times his endeavors to the best of his ability to forward the growth of this organization.

#### SECTION 2:

The Bishop, Overseer must be in full knowledge of the doctrine of this organization. He must always be ready to answer questions correctly and in good faith give advice, judge the members giving every man justice according to the will and the word of God, respectively towards people;

#### SECTION 3:

The Bishop/Overseer may be removed from office for *incompetence and for violating the laws of the NEW TESTAMENT.*

#### SETION 4:

The Bishop/Overseer may be tried for the violation; upon charges in writing preferred and signed by a minister, an officer or three member of this organization; acpy of such charges must first be sent to the Secretary of the Board of Directors. The Board of Directors is to investigate the matter. If in their judgments there is significant grounds fro such accusation written charges shall be prepared and sent to the Secretary of the General Assembly Starting the nature of the charge the Secretary of the General Assembly shall immediately sent a copy to the accused Bishop/Overseer and issued a call for the general Assembly to try such charges which shall coven in not less thirty days no more than sixty days.

SECTION 5:

The Bishop/Overseer shall forward to teach pastor of the church or congregation an official pastoral, ordain who is in good faith as a minister in a church according to the word of God.

SECTION 6:

It shall be the duty of the Bishop/Overseer to bring suit in the Civil Court of the land against any person or corporation when necessary to protect the property or rights of this corporation. He shall likewise defend any suit that *may be instituted against the corporation.*

Article #12 The General Board of Directors

The General Board of Directors Shall composed of not less than three people. Rev. Sam Corgelas SR. and his successors Anes Charles and DeRanot Charles shall always serve as a member of the Board of Directors and serve the Chairman thereof, without the necessity of election. The other *Directors shall be appointed by Rev. Sam Corgelas Sr. and his successors* Anes Charles and DeRanot Charles.

Article #13

The by-laws of the corporation are to be initially made the first Board of Directors, subject to the prior approval of Rev. Sam Corgelas Sr. and his successors Anes Charles and DeRanot Charles a special meeting to be called fro that purpose.

Article #14

Amendments to by laws and these articles of Incorporation may be made by a majority vote of the General Assembly of the State, mother church at any special meeting called for that purpose after giving at less then days notice to the membership of the general Assembly All such purposed amendments to the charter and by the bylaws of this corporation shall be the prior approval of Rev. Sam Corgelas Sr. and his successors Anes Charles and DeRanot Charles,

### Article 15 Qualification Duties of the Pastors

#### SECTION 1:

It shall be his duty to preach, teach, exalt and rebuke with long suffering to the pastor and preside in the congregation, which he has been appointed or approved.

#### SECTION 2:

The pastor is the chief executive officer of the local church and has general oversight and supervision thereof.

#### SECTION 3:

The office of the Pastor places him in the position to obtain any promotion in the Organization and church where in is eligible but he shall at all times be in subjection to them that have rule over him attending and giving his support to the National and local meeting (CONVOCATION, CONFRENCES and ESSEMBLIES).

#### SECTION 4:

All Pastors shall be held responsible to see that each member does his duty to the Bishop/Overseer and the church in general. Any pastor who violates these bylaws may be called in question by his supervisor.

#### SECTION 5:

All Pastors of this organization must be converted and filled with the Holy Ghost. He must be licensed and in good moral standing, and in fellowship with the laws and regulations of the church.

#### SECTION 6:

The Pastor must see that a good financial record is kept and is available for audit at any given time.

#### SECTION 7:

The Pastor Must be in the good knowledge of all movies collected within the church; must be ready at any time giving accountant of finds whenever asked by the Overseer of is district.

#### SECTION 8:

A quarterly report is to be submitted to the Overseer to see the progress of the church. A report to show increases and decreases in membership, and financial report.

#### SECTION 9:

The Pastor, must see that all person handling money are trustworthy or bonded. He is to see that all money is sent or places.

#### SECTION 10:

*The Pastor secretary, and treasurers names must appear on the bank signature card, but only two signatures needed for withdrawal.*

#### SECTION 11:

The state account must include the State Overseer signature plus two other signatures.

#### SECTION 12:

All Pastors must pay tithe as to be a good example to the congregation that they may follow.

### Article 16: Qualification/ Duties of the Elders

#### SECTION 1:

He must possess the qualities of grace required in the NEW-Testament scripture namely conversion and the Holy Ghost. He must have *knowledge and wisdom as to be able to rightly divide the word of truth.* His conduct must be of high moral standing in order that his ministerial work may be effective. He must be able to defend the doctrine of the Faith Assembly of God. In order to protect all under its auspice.

#### SECTION 2:

It is the duty also as an elder to preach and support his superiors in any matter that is called upon as serving the church. He shall be sober, Grave, Temperate, sound in faith, in charity, in patience. All elders must have his membership in some local Church and must his duty as a local member. He is not to make any business transactions in the absence of the pastor. He must report to the pastor at all times. Nor shall he hold private meetings with any one in the congregation.

### Ordained Holders

#### SECTION 3:



No minister can receive ordination in the church until he has pastured or organized at least one Church. The newly organized church mission must be in existence for at least two years with all reports being made and a good record. He must be recommended by his supervisor I.e. (Bishop/Overseer) and posses all qualification required. The elder will not be giving credentials until he has acquainted himself with the doctrine and constitution of the church.

#### SECTION 4:

*The local elders should be personally convinced of this call to the ministry.* He must be willing to study, to show himself approved a workman. He should one that as served faithfully in attendance, tithing, offering, obedience and supporting to his pastor. Preaching conducting worship activates, visiting jail, hospital and may be serve as Shepperd of the pastor is absent.

### Article #17: Members

#### SECTION #1:

Members of the 1ST ASIAN ASSEMBLY OF GOD INC. Any person who is a believer in the Lord Jesus Christ, such as saved by grace through faith sanctified through the and redeemed through the blood of Jesus Christ. This privilege is to worship God in spirit and truth, to have fellowship with Christ and to look for coming.

#### SECTION #2:

Members of the 1ST ASIAN ASSEMBLY OF GOD INC. . All people who shall in good faith join in the various places of assembly maintained by this organization to worship the Almighty God and truth perspective of denomination or creed.

#### SECTION #3:

Members of the Church their duty is to serve, sacrifice, suffer and to defend the faith of the church by their holy congregated lives. Members of the church shall be member of some local body. No member shall join more than two auxiliaries.

#### SECTION #4:

Members of the local Churches shall be chosen by the deacon and Pastor of said Church with the right to appeal to the Overseer.

### Article #18: Qualification of Board Membership

The qualification for membership in the corporation and to the Board of administration are in the spiritual faith and the doctrinal according to the laws of the organization.
