Article I Name

The name of the corporation is South Florida Senior Residences, Inc.

Article II Principal Office

The street and mailing address of the initial principal office of the corporation is 1801 Clint Moore Road, Suite 200, Boca Raton, Florida 33487.

Article III Purpose

Subject to Article VII below, the purpose for which the corporation is organized is to operate one or more senior living facilities, to provide ancillary services to the residents of such facilities, and to engage in any other lawful activities in furtherance thereof, including, but not limited to, operating ancillary facilities for the benefit of such residents.

Upon the dissolution of the corporation, its assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. A ny such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.
