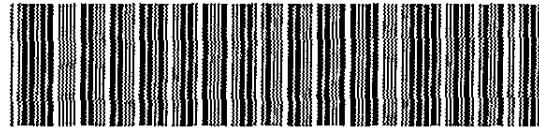

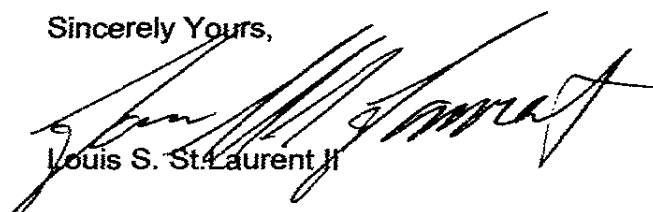

ARTICLES OF INCORPORATION OF
CLUB ALOUETTE MEADOWS, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act.

ARTICLE I NAME

The name of the corporation shall be:

CLUB ALOUETTE MEADOWS, INC.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III PURPOSE(S)

The specific purpose for which the corporation is organized is to organize and provide social and recreational functions and events for the residents of the Meadows. :

ARTICLE IV POWERS

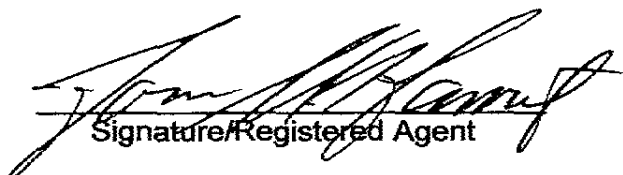
