## ARTICLES OF INCORPORATION OF I NEED TO TALK MINISTRIES, INC.

### A FLORIDA NOT-FOR PROFIT CORPORATION

The undersigned, being natural persons over eighteen years of age, acting as incorporator of a not for profit corporation pursuant to Chapter 617, F.S., Florida Statues ("Florida Not For Profit Corporation Act"), adopts the following articles of incorporation and states as follows:

### ARTICLE I - NAME

The Name of the corporation is I Need to Talk Ministries, Inc. (hereinafter the "Corporation")

### ARTICLE II - PRINCIPAL OFFICE

The principal office of the Corporation and the mailing address of the Corporation is: P.O. Box 151167
Altamonte Springs, Florida 32715

### ARTICLE III - PURPOSE

The Corporation is organized exclusively for religious, charitable, and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986(or corresponding provision of any future United States Internal Revenue law), including, but not limited to providing food to the hungry, aid to the homeless, safe shelter for women, and a women's telephone support hotline.

### ARTICLE IV - MANNER OF ELECTION

The initial board of directors of the Corporation shall be appointed by the incorporator. The Corporation shall have no members. The affairs of the corporation shall be managed by the board of directors. The number of directors shall be fixed by the bylaws of the corporation, but may not be less that three(3).

### ARTICLE V - REGISTRED OFFICE AND AGENT

### ARTICLE VII - TERM OF CORPORATE EXISTENCE

The period of duration of the corporation is perpetual.

### ARTICLE VIII - PRIVATE INURMENT

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the tax-exempt purposes of the corporation set forth in Article III.

### ARITICLE IX - POLITICAL ACTIVITIES

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

### ARITICLE X - RACIAL NONDISCRIMINATION

The corporation shall have a racially nondiscriminatory policy and, therefore, shall not discriminate against applicants, students, employees, and others on the basis of race, color, or national or ethnic origin.

### ARITICLE XI - DISSOLUTION

Upon the dissolution of the corporation, the board of directors shall, after paying or making provision for payment of all the liabilities of the corporation, transfer all assets to a fund, foundation, or organization which is organized and operated exclusively for charitable, religious, or educational purposes and at that time qualifies as an organization exempt from federal income taxation under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).

### ARITICLE XII - EXEMPT ACTIVITIES

Notwithstanding any other provisions of these Articles, the corporation shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law) or by an organization, contributions to which are deductible under Section 170(c) (2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).
