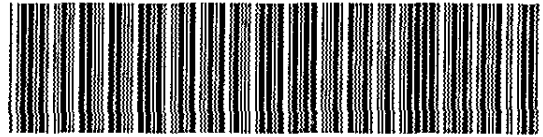



ARTICLE VIII

DISTRIBUTIONS OF LIQUIDATION OR DISSOLUTION

Upon the dissolution of the Corporation, or the liquidation of its' assets, whether voluntary or involuntary of by law, the Board of Directors shall, after paying or making provisions for the payment of all liabilities of the Corporation, distribute all of the assets of the Corporation exclusively for the purposes of the Corporation, in such manner, or to such organization or organizations organized and operated exclusively for the purposes of the Corporation, in such a manner, or to such organization or organizations organized and operated exclusively for charitable or educational purposes as hall at the time qualify as an exempt organization or organizations under Section 501 (c) (3) of Code, as the Board of Directors shall determine. Any of such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is located, exclusively for such purpose, or to such organization or organizations, as said court shall determine, which are organized and operated for such purposes. In no event shall any of the net assets of the Corporation be distributed to or for benefit of any member, officer, or director of the Corporation or to any other individual; provided, however, that nothing contained in this Article shall be construed to prevent distribution from the net assets of the Corporation to another distributees, otherwise properly made in accordance with the provisions of these Articles and purposes herein stated solely by reason of the fact that one or more of the members, officers, or directors of the Corporation may be connected or associated with the distributee as a shareholder, member, trustee, director, officer or in any other capacity.
