ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be: Christ Like Ministry, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:
1034 Lobster Lane, Jacksonville, Florida 32218

ARTICLE III PURPOSES

The specific purpose for which the corporation is organized is: The corporation is not organized for pecuniary gain or profit and is organized under the Florida Corporation Not for Profit Code for the specific primary purpose of operating for the advancement of faith under Christian principles which shall include, but shall not be limited to, the following: (a) To conduct worship services in the manner prescribed in the New Testament; (b) To edify Christians with teachings of the Scriptures; (c) To seek universal fellowship with Christians for the testimony of God; (d) to preach the gospel of Jesus Christ; (e) To minister spiritual and temporal needs of the poor, sick, orphans and widows according to brotherly love inspired by God; (f) To engage in home and foreign missionary activities in cooperation with affiliated local churches in furtherance of the herein described purposes; and (g) To perform and operation and to conduct any affairs authorized by the Florida Corporations Not for Profit Code and to conduct and perform any and all activities that may be related, no matter how remote, to any of the foregoing.

This corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.


ARTICLE VI DISSOLUTION

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal tax code, or shall be distributed to the Federal, state, or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes.
