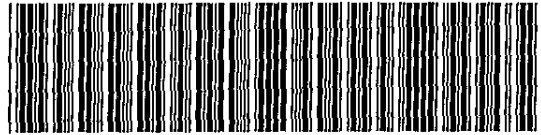

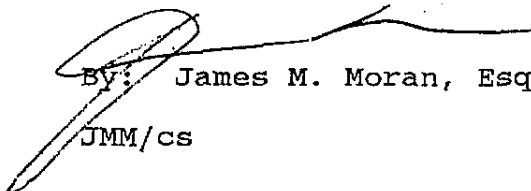

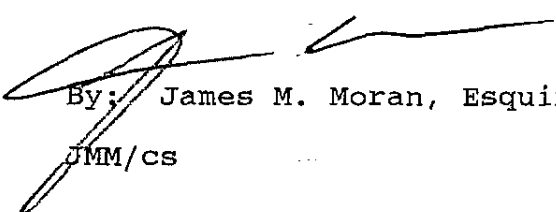

ARTICLES OF INCORPORATION
OF

Ministerio Evangelistico Desenmascarando al diablo, Inc.

A FLORIDA NOT FOR PROFIT CORPORATION

The undersigned persons, acting as incorporators of a corporation not for profit under the Florida Not For Profit Corporation Act, as set forth in Chapter 617 of the Florida Statutes, adopt the following Articles of Incorporation for the corporation:

Article I

The name of the corporation is Ministerio Evangelistico Desenmascarando al diablo, Inc.

Article II

The corporation shall have perpetual duration from the date of filing of these articles.

Article III

The corporation is a not for profit corporation. The purposes for which the corporation is organized are:

To provide Biblically-based Christian Ministries for Evangelistic preaching at different congregations throughout the United States of America. These churches are within the Christian Pentecostal faith and the corporation shall provide ministers to preach at those churches upon those churches invitation and consistent with the Christian Pentecostal guidelines. This ministry shall be conducted according to traditional Christian values and be conducted on a non profit basis.

(a) The specific and primary purpose for which this corporation is formed is to advance the Christian religion, perform Evangelical preaching, conduct religious charity, and religious Evangelical education for charity and religious purposes. The persons given ministry throughout the corporation are recognized ministers within the Pentecostal faith as ordained ministers and are invited on a regular basis to Christian Pentecostal congregations throughout the United States of America.

(b) The general purpose for which this corporation is formed is to operate exclusively for religious, charitable, and educational purposes which will qualify as an exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1986 or corresponding provisions of any subsequent federal tax laws, including, for those purposes, the making of distributions to

organizations which qualify as tax-exempt organizations under that Code.

(c) This corporation shall not, as a substantial part of its activities, carry on propaganda or otherwise attempt to influence legislation; nor shall it participate or intervene by publication or distribution of any statements or otherwise in any political campaign on behalf of any candidate for public office.

Article IV

The corporation shall have a membership distinct from the board of directors. The authorized number and qualifications of the members of the corporation, the manner of their admission, the different classes of membership, if any, the property, voting, and other rights and privileges of members, and their liability for dues and assessments and the method of collecting dues and assessments shall be as regulated in the bylaws.

Article V

The street address of the initial registered office of the corporation is 513 S.W. 28th Street, Cape Coral, Florida 33914. This address is in the County of Lee and the State of Florida. The name of its initial registered agent at that address is Jesus Manuel Bermudez. THIS IS ALSO THE PRINCIPAL OFFICE.

Article VI

The powers of this corporation shall be exercised, its property controlled, and its affairs conducted by a board of directors. The number of directors of the corporation shall be not less than three; provided, however, that number may be changed by a bylaw duly adopted pursuant to the bylaws of this corporation.

The directors named here as the first board of directors shall hold office until the first meeting of members, to be held on March 25, 2003 at 10:00 a.m., at 513 S.W. 28th Street, Cape Coral, Florida 33914, at which time an election of directors shall be held.

Directors elected at the first annual meeting, and at all subsequent times, shall serve for a term of one year until the second annual meeting of members following the election of directors and until the qualification of the successors in office. Annual meetings shall be held at 10:00 a.m., on the first Monday in March of each year at the principal office of the corporation, or at any other place or places designated by the board of directors by resolution.

Any action required or permitted to be taken by the board of directors under any provision of law may be taken without a meeting, if all the members of the board individually or collectively consent in writing to the action. Written consent or consents shall be filed with the minutes of the proceedings of the board, and any action by written consent shall have the same force and effect as if taken by unanimous vote of the directors. Any certificate or other document filed under any provision of law that relates to action taken in this manner shall state that the action was taken by unanimous written consent of the board of directors without a meeting and that the Articles of Incorporation and bylaws of this corporation authorize the directors to act in this manner. This statement shall be prima facie evidence of the directors' authority.

Article VIII

The board of directors shall elect the following officers: President and Secretary/Treasurer and any other officers which the bylaws of this corporation authorize the directors to elect.

Initially, officers shall be elected at the first annual meeting of the board of directors. Until that election is held, the following persons shall serve as corporate officers:

Article IX

Subject to the limitations contained in the bylaws and any limitations set forth in the Not-For Profit Corporation Act of Florida described above, concerning corporate action that must be authorized or approved by the members of the corporation, the bylaws of this corporation may be made, altered, rescinded, added to, or new bylaws may be adopted, either by a resolution of the board of directors or by following the procedure set forth in the bylaws.

Article X

The property of this corporation is irrevocably dedicated to charitable and religious purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer, or member, or to the benefit of any private individual.

Article XI

On the dissolution or winding up of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the corporation, shall be distributed to a not for profit fund, foundation, or corporation which is organized and operated exclusively for religious purposes and which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding provisions of any subsequent federal tax laws.

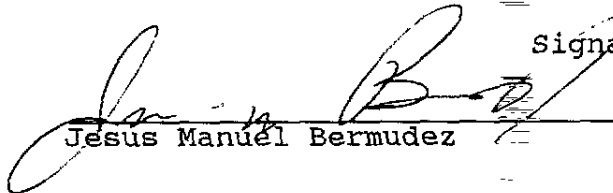
Article XII

Amendments to these articles of incorporation may be proposed by a resolution adopted by the board of directors and presented to a quorum of members for their vote. Amendments may be adopted by a

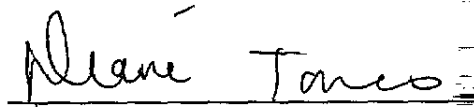

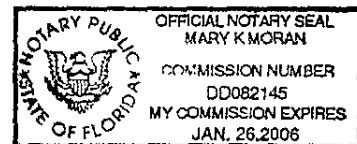

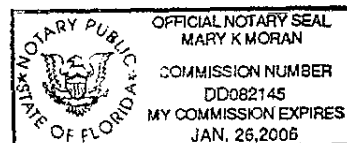
