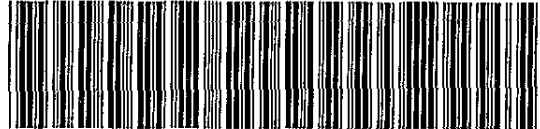



ARTICLES OF INCORPORATION
OF
HELPFUL HAND HOMECARE, INC.

WE, the undersigned, residents of the State of Florida, pursuant to Chapter 617 Florida Statutes, have associated ourselves together and hereby associate ourselves together for the purpose of becoming incorporated under the Laws of the State of Florida, as a corporation, not for profit, pursuant to these articles of incorporation.

ARTICLE I. NAME

The name of the corporation is: HELPFUL HAND HOMECARE, INC.

ARTICLE II OBJECTS

A. The specific and primary purposes are:

- (1) The purposes for which the corporation is organized are exclusively charitable, scientific, literary, religious and educational, within the meaning of section 501 (c) (3) of the Internal Revenue Code of 1954 or the corresponding provisions of any future United States Internal Revenue Law.
- (2) Notwithstanding any other provisions of these articles, this organization will not carry on any activities not permitted to be carried on by organizations exempt from Federal Income Tax under section 501 (c) (3) of the Internal Revenue Code of 1954 or the corresponding provisions of any future United States Internal Revenue Law.
- (3) The Corporation is irrevocably dedicated to and operated exclusively for non-profit purposes and no part of the income or assets of the corporation shall be distributed to, or inure to the benefit of any individual.

B. In furtherance, but not in limitation of the foregoing charitable, scientific, literary, religious and educational purposes, the corporation shall have the following powers:

- (1) To buy, own, sell, assign, mortgage, or lease any interest in real estate and personal property and to construct, maintain, and operate improvements thereon, necessary or incidental to the accomplishment of the purposes set forth herein.
- (2) To borrow money and issue evidence of indebtedness in furtherance of any or all of the objects of its business and to secure the same by mortgage, pledge, or other lien on the corporation's property.
- (3) To provide such community and or support services, including but not limited to home and or institutional care as may be deemed appropriate and or necessary or incidental to any or all of its stated objects.

ARTICLE III MEMBERSHIP

Membership in the corporation shall be open to such persons or organizations that share in the vision or stated goals of the corporation and who make application for membership in such manner and such form as may be stipulated by such by-laws as may be in force from time to time.

ARTICLE IV EXISTANCE

This corporation shall have perpetual existence.

ARTICLE VI BOARD OF TRUSTEES

This corporation shall have three (3) Trustees initially, the number of trustees may be increased or diminished from time to time by bylaws adopted by the members and Board of Trustees, but shall never be less than three. The bylaws shall determine those persons elected as Trustees. The Trustees shall be elected from the membership during the annual business meeting.

ARTICLE VIII PRINCIPLE OFFICE

ARTICLE IX AMENDMENT

These articles of incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Trustees, proposed by them to the members, and approved at a regularly convened meeting of members by a simple majority vote of members. Provided that any amendment may be made by the unanimous written decision of all members of the Board of Trustees and all members of the corporation entitled to vote. Provided, however, that nothing herein, or heretofore, shall preclude necessary typographical, grammatical or purely cosmetic or non-consequential amendments.

ARTICLE X. ORGANIZATION OF THE CORPORATION

This corporation is organized on a non-stock basis.

ARTICLE XI TAX EXEMPT STATUS

No part of the income or losses of this corporation shall be distributed to its members and/or trustees, except as compensation for actual services rendered. In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in section 501 (c) (3) and 170 (c) (2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future law, or the Federal, State or Local Government for exclusive public purpose.
