ARTICLE I

Corporate Name

The name of this corporation is **INDEPENDENT LIVING FOR RETARDED ADULTS FOUNDATION, INC.**

ARTICLE II

Initial Principal Office

The initial principal office of this corporation shall be 8660 S.W. 27th Avenue, Ocala, Florida 34476. The initial mailing address of this corporation shall be 8660 S.W. 27th Avenue, Ocala, Florida 34476.

ARTICLE III

Purposes

To receive and administer funds for scientific, education, and charitable purposes and to that end to take and hold by bequest, devise, gift, grant, purchase, lease or otherwise, any property, real, personal, tangible, or intangible, or any undivided interest therein, without limitation as to amount or value; to sell, convey, or otherwise dispose of any such property and to invest, reinvest, or deal with the principal or the income thereof in such manner as, in the judgment of the directors, will best promote the purposes of the Corporation without limitation, except such limitations, if any, as may be contained in the instrument under which the property is received, these Articles of Incorporation, the By-laws of the Corporation, or any laws applicable thereto.

For any other lawful purposes pursuant to *Florida Statutes* and the powers conferred upon non-profit corporations under the laws of the State of Florida.

ARTICLE IV

Corporate Nature

This is a nonprofit corporation organized under the laws of the State of Florida pursuant to Chapter 617, *Florida Statutes*.

Upon dissolution of this corporation, the Board of Directors shall, after paying or making provisions for the payment of all the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation and in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious or scientific purposes as shall at the time qualify as an exempt organization under Section 501(c)(3) of the *Internal Revenue Code* as it now exists or may hereafter be amended, as the Board of Directors shall determine. Any such assets not so disposed of shall be disposed of by the Circuit Court of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations as said Court shall determine, which are organized and operated exclusively for such purposes.

No part of the income or net earnings of this corporation shall be distributable to its members, directors or officers.

Notwithstanding any other provisions of these Articles of Incorporation, no member, director, officer, employee or representative of this corporation shall take any action or carry on any activities by or on behalf of the corporation not permitted to be carried on by an organization exempt under Section 501(c)(3) of the *Internal Revenue Code* and its Regulations as they now exist or may hereafter be amended, or which are not permitted to be taken or carried on by an organization, the contributions to which are deductible under Section 170(c)(2) of such Code and Regulations as they now exist or as they may hereafter be amended.

This corporation shall have perpetual existence.
