ARTICLES OF INCORPORATION OF

NO THRE IN THE

Dinner Lake Haven Homeowners Association, Inc.

The undersigned, being not less than two-thirds of all of the mobile home owners of Dinner Lake Haven Mobile Home Park, for the purpose of forming a nonprofit corporation under Florida Statutes Chapter 517, do hereby make and adopt the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation is "Dinner Lake Haven Homeowners Association, Inc."

ARTICLE II. NOT FOR PROFIT

The Corporation is a nonprofit corporation under the laws of the State of Florida. The Corporation is not formed for pecuniary profit. No part of the income or assets of the Corporation is distributable to or for the benefits of its Members, Directors or Officers, except to the extent permissible under law.

ARTICLE III. PURPOSES

The Corporation is organized and shall be operated exclusively as a non-stock organization for the following purposes:

- (a) To establish an association that provides a forum for the discussion of, and action on, items of common interest of homeowners of mobile homes located at Dinner Lake Haven Mobile Home Park in Highlands County, Florida;
- (b) To provide recreational, social, and other activities of interest to the members;
- (c) In order to exercise the rights provided in Florida Statutes 723.077 including, but not limited to, exercising its right to negotiate for, acquire and operate the mobile home park of Dinner Lake Mobile Home Park on behalf of the mobile home owners;
- (d) In order to exercise its right to convert the mobile home park to a condominium, a cooperative form of ownership, or other type of ownership pursuant to Florida law;
- (e) To exercise and engage in any other powers or business of mobile home park associations as permitted by Florida law; and
- (f) To engage in any lawful activities which are in furtherance of the purposes of the Corporation as described herein.

ARTICLE IV.

DURATION AND TIME AND DATE OF COMMENCEMENT

The duration of the Corporation is perpetual, and the Corporation shall commence at the time and date of filing of these Articles with the Secretary of State.

ARTICLE V. LIMITATION

No part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its Members, trustees or Officers, but the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III (Purposes) hereof.

ARTICLE VI. MEMBERS

The Corporation shall have Members who shall have all rights and privileges of voting members of the Corporation. The qualification for members and the manner of their admission shall be as stated in the bylaws. The names of the initial Members are as listed on Exhibit "A".

ARTICLE VII. INITIAL REGISTERED OFFICE AND AGENT

The street address of the Initial Principal and Registered Office of the Corporation is 2900 SR 17 N Lot 8, Sebring Florida 33870, and the name of its initial Registered Agent is Donna Rhine.

ARTICLE VIII. INITIAL BOARD OF DIRECTORS

The management of the Corporation shall be vested in a Board of Directors. The number of Directors constituting the initial Board of Directors is five (5). The number of Directors may be increased or decreased from time to time in accordance with the bylaws, but shall never be less than three (3). The Members of the Corporation shall elect the Directors as provided in the bylaws. The initial Directors are:

ARTICLE IX. OFFICERS

This Corporation is organized on a nonstock basis. This Corporation shall not issue shares of stock.
