

## FIRST AMENDMENT TO THE ARTICLES OF INCORPORATION

OF

MICHAEL SCHOLZ MEMORIAL CHARITABLE FUND, INC.

## ARTICLE I and any members.

Article IV of the Articles of Incorporation are hereby amended to read as follows:

- (1) The corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.
- (2) No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof.

- (3) No substantial part of the activities of the corporation shall consist of carrying on propaganda, or otherwise attempting, to influence legislation; nor shall it in any manner or to any extent participate in, or intervene in (including the publishing or distributing of statements), any political campaign on behalf of any candidate for public office; nor shall the corporation engage in any activities that are unlawful under applicable federal, state, or local laws.
- (4) The corporation shall not (a) operate for the purpose of carrying on a trade or business for profit, (b) engage in any prohibited transactions as described in \$503 of the Code and (c) accumulate income, invest income, or divert income, in a manner endangering its exempt status by virtue of \$504 of the Code.
