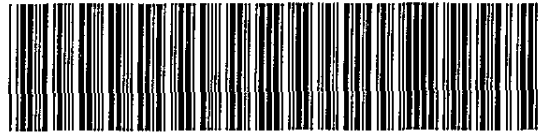



OF

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, and a citizen of the United States, desiring to form a non-profit corporation under the laws of the State of Florida, do hereby certify:

ARTICLE I. NAME

The name of this corporation shall be:

ARTICLE II. ADDRESS

The initial street address of the principal office of the corporation in the State of Florida shall be 514 Mellonville Ave, Sanford, FL. 32771, Seminole County. The Board of Directors may from time to time move the principal office to any other place or places as may be designated by the Board of Directors.

ARTICLE IV. REGISTERED OFFICE AND REGISTERED AGENT

The street address of the office registered for the corporation shall be 514 Mellonville Ave, Sanford, FL 32771. The initial registered agent shall be Monique Shine.

ARTICLE V. PURPOSE

ARTICLE VII. PROHIBITED ACTIVITES


No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501 © (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to federal government, or to a state or local government, for public purposes. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction in the county in which the principal office of the corporation is then located.

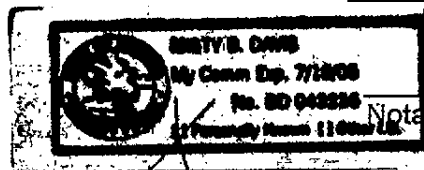



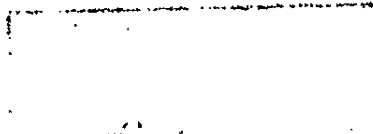
