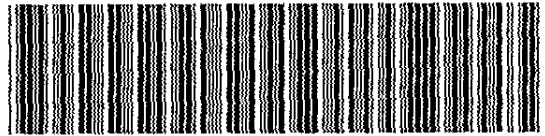

The undersigned acting as Incorporator, for the purpose of forming a Corporation under the provision of chapter 617 of Florida Statutes, The Florida Not For Profit corporation Act, Hereby adopt the following Articles of Incorporation:

ARTICLE I NAME AND DURATION

The name of the corporation shall be: THERAPY FOR KIDS, INC. This corporation is non-stock and it is to exist perpetually commencing at the time of filing the articles of incorporation with the department of state.

ARTICLE II PRINCIPLE OFFICE

ARTICLE III PURPOSE (S)

Pursuant to section 501. ©3, Section 170©2 of the Internal Revenue Code and Chapter 496 of Florida Statutes, This Corporation is organized to serve the community specifically for charitable, educational and philanthropic purposes.

ARTICLE IV MANNER OF ELECTION OF DIRECTORS

Upon dissolution, all of the remaining assets after payment of debts, cost and expenses shall be distributed to other non-profit companies under 501.c3, for public and charitable purposes. All other powers are as set forth in the bylaws.

The corporation shall indemnify all directors, officers and employees and any former officers, directors and employees to the fullest extent permitted by law. The articles may be amended at any time by the incorporator or as set forth in the bylaws.


