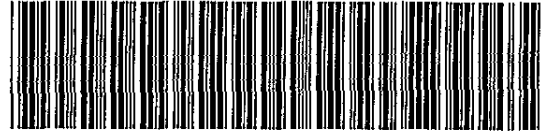

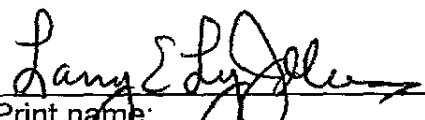

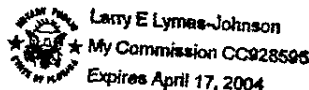

In compliance with Chapter 617, Florida Statutes, the undersigned incorporator hereby forms a corporation not for profit (the "Corporation") as follows:

ARTICLE I - NAME

The name of the corporation shall be:

Gold Coast Aikikai, Inc.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

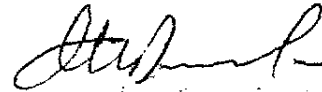
