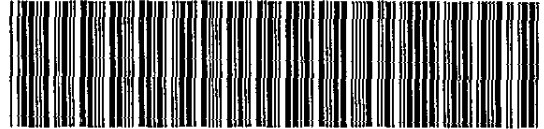

## Articles Of Incorporation

In Compliance with Chapter 617, F.S., (Not for Profit)

### Article I

The name of the corporation shall be: Okaloosa Performance Group Inc.

### Article II

The principal place of business and mailing address of this corporation shall be: P. O. Box 2811, Ft. Walton Beach, Fla. 32549

### Article III
