ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not For Profit)

ARTICLE I NAME

The name of the corporation shall be: Pettidee Ministries, Inc.

ARTICLE I I PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: The City of Jacksonville,

the state of Florida and the county of Duval.

ARTICLE III PURPOSE

Said Corporation is organized exclusively for charitable, religious, educational, and scientific purposes including, for such purposes making of distribution to organizations that qualify as exempt organizations under section 501(c) 3 of the internal revenue code, or the corresponding section of any future federal tax code. The Purpose for which this corporation is organized is to minister to youth and teens the Gospel of Jesus Christ through preaching and gospel music. This Ministry has and will continue to visit Junior High Schools, High Schools, Juvenile Detention Centers and prisons across the country. Pettidee Ministries deals with issues such as school shootings, peer pressure, drug use and selling. The idea is to show the children, teens and adults that Pettidee Ministries has a positive message and way of life, through our Testimonies and providing a living example of the message of Jesus Christ as written in the Holy Bible. The intent of this Ministry is to reveal the Truths about ungodly behavior and criminal living through a series of Documentary Films about prison and street life. These films will be a vehicle, which shows from start to finish, the true impact of how bad decision-making can lead to ungodly behavior.

The music is performed by Pettidee, who is also a vehicle for the message of Christian living versus ungodliness. His music is geared towards a youthful audience, specifically teens and young adults. The overall picture is to use the powerful tool of music to reach, preach and teach the message of Jesus Christ as described in the Holy Bible. Which is represented through the Gifts and Talents that God has given Pettidee, who is a living reflection of this message. This ministry stands upon the scripture of Luke 4:18 "The Spirit of the Lord is upon me, because he hath anointed me to preach the gospel to the poor; He hath sent me to heal the brokenhearted, to preach deliverance to the captives, and recovering of sight to the blind, to set at liberty them that are bruised."

### ARTICLE V NET EARNINGS

No part of the Net earnings of the corporations shall inure to the benefit of, or be distributable to its members, trustees, officers, or private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in article third hereof. No substantial part of the activities of the corporations shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Not withstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried (a) by a corporation exempt from federal income tax under sections 501(c) 3 of the internal revenue code, or the corresponding section of future federal tax code, or (b) by a corporation, contribution to which are deductible under section 170(c)(2) of the internal revenue code, or the corresponding section of any future federal tax code.



## **ARTICLE VI Dissolution of Corporation**

Upon the dissolution of corporation, assets shall be distributed fir one or more exempt purposes within the meaning of section 501(c)(3) of the internal revenue code, or the corresponding section of a future federal tax code, or shall be distributed to the federal government, or the corresponding section of an future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets, not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporations is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.
