## ARTICLES OF INCORPORATION

The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a non profit Corporation under 617 of the Florida Statutes.

### **ARTICLE 1 - NAME**

The name of the Corporation is **HYPPOLITE JOSEPH MINISTRIES**, **INC.**, (hereinafter "Corporation).

### **ARTICLE 2 - PURPOSE OF CORPORATION**

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

### **ARTICLE 3 - PROHIBITIONS**
