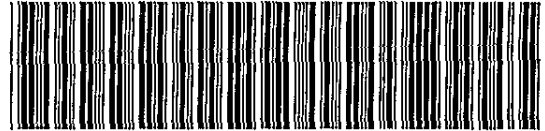

**ARTICLE I**

**The name of this corporation shall be BALL FAMILY DAY CARE OF FORT PIERCE, INC., and it is located at, 2609 Navajo Ave., Fort Pierce, FL 34946.**

**ARTICLE II**

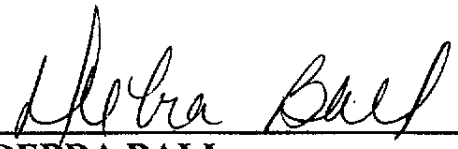

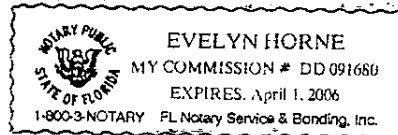
