ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

Article I

Name of Corporation

The name of the corporation shall be **Cuthbert Shooting Preserve, Incorporated**, a not for profit corporation.

Article II

Principal Office

The principal place of business shall be Bartow, Florida and the mailing address shall be 1520 Old Eagle Lake Road, Bartow, Florida 33830.

Article III

Purpose

The specific purposes of the Cuthbert Shooting Preserve shall be to lease hunting property in the southeastern United States; promote fair, equal, and good sportsmanship between individuals while participating in hunting activities; protection of the environment; and proper wildlife management.

Article IV

Board of Directors and Officers

There shall be three (3) directors elected for a one (1) year term by a majority of Corporation members attending the annual meeting. The newly elected directors shall select a President, Vice President, Secretary and Treasurer, who shall also serve a one (1) year term. The President, Vice President and Treasurer **must** be members of the Board of Directors.

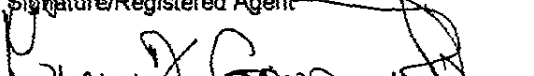
