## ARTICLES OF INCORPORATION OF BAY COMMUNITY INVESTMENTS, INC.

The undersigned, acting as Incorporator of a Corporation pursuant to Chapter 617, adopts the following Articles of Incorporation for such corporation:

### ARTICLE I NAME

The name of the non-profit corporation is:

### BAY COMMUNITY INVESTMENTS, INC.

The principal place of business shall be:

539 Harmon Ave. Panama City, Florida 32401

### ARTICLE II CORPORATE DURATION

The duration of the corporation shall be perpetual unless dissolved according to law.

### ARTICLE III PURPOSES

1. The Corporation is organized exclusively for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code (or the corresponding portions of any future United States Internal Revenue Law), including to the extent permitted by said Section 501(c)(3), the redevelopment, promotion, up-grading, and rehabilitation of the cultural, historical, social and economic aspects of Bay County, Florida, and its environs to provide decent housing that is affordable.

No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distributing of statements) any political campaign on behalf of any candidate for public office.

This Corporation is and shall remain a Corporation not for profit. The Corporation shall not have nor issue shares of stock. No dividends shall be paid, and no part of the net earnings of the Corporation shall inure to the benefit of its members, directors or officers, or to the benefit of any private shareholder or individual.

- 2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act or engage in any other trade or business which can, in the opinion of the board of directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.
- 3. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

### ARTICLE IV MEMBERS

Any person interested in furthering the purposes of the Corporation may become a member upon signing and delivering to the Secretary of the Corporation a membership application form and meeting such uniform conditions as may be prescribed by the Board of Directors.

### ARTICLE V CAPITALIZATION

The corporation is organized under a non-stock basis.

#### ARTICLE VI REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the corporation is 539 Harmon Ave, Panama City, FL 32401, and the name of it's initial registered agent at such address is Ronnie H. Adams

#### ARTICLE VII MANAGEMENT

The business, property and affairs of the Corporation are to be managed by a Board of Directors, and officers of which are to be a President, a Vice-President, a Secretary, a Treasurer, and such other officers as may be provided by the By-Laws or as may from time to time be elected or appointed. The aforementioned officers shall be elected each year by the Board of Directors at its annual meeting.

### ARTICLE XII BYLAWS

Provisions for the regulation of the internal affairs of the corporation are governed by the bylaws which shall be adopted by a majority of directors.

### ARTICLE XIII AMENDMENT

This corporation reserves the right to amend or repeal any provisions contained in the By-Laws, Articles of Incorporation and any amendment thereto, and any right conferred upon the membership is subject to this reservation.


