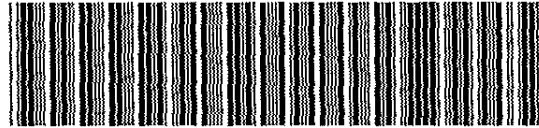

**ARTICLES OF INCORPORATION

The undersigned, by these Articles of Incorporation, associate themselves for the purpose of forming a corporation not for profit, pursuant to the provisions of Chapter 617, Florida Statutes, and certify as follows:

**ARTICLE I
NAME**

The name of the Corporation shall be CITIZENS CONCERNED FOR THE FUTURE OF INDIAN RIVER COUNTY, INC. For convenience, the corporation will be referred to in this instrument as the Corporation. The initial business office shall be 1701, Highway A-1-A, Suite 220, Vero Beach, Florida, 32963. The Mailing address shall be 1701, Highway A-1-A, Suite 220, Vero Beach, Florida, 32963, Attn: Ira C. Hatch, Esq.

**ARTICLE II
EXISTENCE AND DURATION**

Existence of the Corporation shall commence with the filing of these Articles of Incorporation with the Secretary of State, Tallahassee, Florida. The Corporation shall exist in perpetuity.

**ARTICLE III
PURPOSES**

The Corporation is organized for the purpose of promoting the responsible development and growth of Indian River County in such a manner as to improve the quality of life for all of its citizens and to undertake all activities allowed under Chapter 106 fo the Florida Statutes (2002) for a political committee or a committee of continuous existence as defined therein.

**ARTICLE IV
MEMBERSHIP QUALIFICATION**

Any person who has an interest in this cause shall be eligible for membership upon approval by the Board of Directors.

ARTICLE V
DIRECTORS

The number and method of selecting directors shall be as stated in the Bylaws of the Corporation.

ARTICLE VI
NOT-FOR-PROFIT ORGANIZATION

This Corporation is organized under a non-stock basis and shall at all times be operated as a not for profit organization.

ARTICLE VII
DISSOLUTION

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Section 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future law, or to the Federal, State, or Local Government for exclusive public purposes.

ARTICLE VIII
AMENDMENT OF BY-LAWS AND ARTICLES

The By-Laws of the Corporation are hereby adopted and shall be amended by a two-thirds (2/3) affirmative vote of the entire Board of Directors. The Articles of the Corporation shall be amended by a seventy-five percent (75%) affirmative vote of the entire Board of Directors.

ARTICLE IX
DESIGNATION OF INITIAL REGISTERED OFFICE AND REGISTERED AGENT

The street address of the initial registered office of the Corporation is: 1701 Highway A-1-A, Suite 220, Vero Beach, FL 32963, and, the name of the initial registered agent of the Corporation at that address is Ira C. Hatch.
