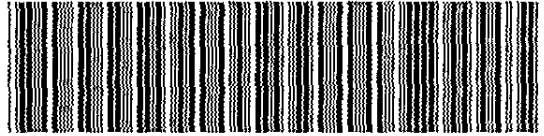

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The purpose for which the corporation is organized is:

The purpose or purposes for which the corporation is formed are as more fully set forth in the Discipline of the First United Methodist Church, Chattahoochee, Florida, or as may hereafter, from time to time, be amended including:

- a) The promotion of the Christian religion through the preaching of the Word of God, the administration of the sacraments, ordinances, and other means of grace, the maintenance of worship, the edification of believers, the evangelization of the world, and the promotion of the missionary and benevolence causes.

- e) All of the above shall be in accordance with the Doctrines, Laws, Usages, *Discipline*, and Ministerial appointments of the First United Methodist Church of Chattahoochee.

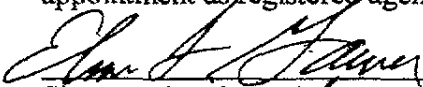
