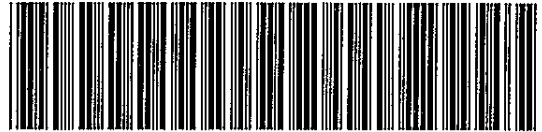

ARTICLE III PURPOSE

- .Encouraging individuals through the Word of GOD
- .Disturbing helpful and informative information about Drug Intervention and Sexual Transmittal Disease
- .Provides food, clothing and Temporary shelter for those individuals who are in need.
- .Semi and Annual banquets consisting of guest speakers, gifts, food, and vendors, contribution are used toward helping fulfill the purpose of the fellowship
- .Minister Debra Fordham is the overseer of United Prayer Warriors and its events, which are funded by donation, fund raising, partners.
