ARTICLES OF INCORPORATION

The undersigned, acting as incorporation(s) of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation of such corporation:

ARTICLE I

NAME

The name of the corporation shall be:

Jesus Christ Fellowship Community Church
A Full Gospel Ministry of Mayo, FL, Inc.

ARTICLE II

PRINCIPLE OFFICE

ARTICLE III

SECTION 2.1 PURPOSE, LIMITATION AND DISSOLUTION

The purpose for which the corporation is organized is: Jesus Christ Fellowship Community Church is a Full Gospel - New Testament Local Church, established by Deacon Lemon Curtis Watson - Chairman of the Deacon Ministry, and Mother Emma Watson-General Mother, and others in the year of nineteen hundred and ninety, an assembly of professing believers in Christ, who have been baptized by the spirit of Christ into his body and organized to carry out the great commission, go ye therefore, and teach all nations, baptizing them in the name of the Father, and of the Son, and Holy Ghost: teaching them to observe all things whatsoever I have commanded you: and lo, I am with you always, even unto the end of the world. Amen (Matthew 28:19-20), and to carry out God's will here on earth as the pillar

and the ground of the truth (I Timothy 3:15). A community of believers, and they, continuing daily with one accord in the temple, and breaking bread from house to house did eat their meat with gladness and singleness of heart, praising God, and having favour with all the people. And the Lord added to the church daily such as should be saved. (Acts 2:46-47); this includes a number of things: observing the ordinances, evangelizing, building up believers, worship services, paying tithes and giving offerings, ministering to all age groups, and to all people etc. The leaders of the Jesus Christ Fellowship Community Church will operate under the congregational type of government which describes:

Authority: the leadership will be led by the Holy Spirit and the word of God. The word of God is the final authority.

Autonomy: Jesus Christ Fellowship Community Church is autonomous, with no individual or organization above it, except Christ Jesus the Son of the living God, and the head and creator of all things, his body; the church. For there are three that bear record in heaven, the Father, the Word, and the Holy Ghost: and these three are one; (I John 5:7). Each member of this New Testament local church body has these souls entrusted to it for protection, development and preparation for the Kingdom of Heaven, and we therefore are duty bound to furnish the best possible public instructions in the gospel and the best training for service to exercise a tender, loving, patient watch care over the members and to use the utmost diligence and effort for there enlightenment, sanctification and usefulness, with the view that we attain perfection in Christ.

Responsibility: congregationalism does not imply that the entire congregation votes on every decision; responsibility is delegated to Jesus Christ Community Fellowship Church officials and leaders though like other members of this local church body they have only one vote in this congregation.

Discipline: the Jesus Christ Fellowship Community Church body is governed by the divine law as laid down by Jesus Christ himself with rules and regulations by which this local church body is governed by the Word of God. The Jesus Christ Fellowship Community

Church method is to keep out everything and to remove everything that may bring reproach, scandal or disgrace upon the household of faith (Gal. 6:10); every member of Jesus Christ Fellowship Community Church pledges their support, but binds themselves to be governed by the New Testament standards of life and principles. The universal law of love comes first barring out suspicious jealousies, hatred and bitterness (John 13:34). Law for the offender - confession (Matt. 5:23-24); guidance of the offended one (Matt. 18:22); let all things be done decently and in order (Titus 1:5; I Cor. 12:12-23; Eph. 4:11-12); (I Cor. 5:1-6). Offenses which are stumbling-blocks to the world and bad examples to others must be dealt with in order that God's church may be true to His law. Some of these are: disorderly walkers (2 Thess. 3:11); immoral conduct (I Cor. 5:11); stirring up strife (I Cor. 11:16); unruly behavior (Matt. 18:18); teaching false doctrine (Gal. 1:9; 2 John 10); covetous and penurious (Eph. 5:5; I Cor. 5:11); arrogant and domineering (3 John 9-10); prosecuting brothers and sisters before unbelievers (I Cor. 6:5-7).

RIGHTS OF AN ACCUSED MEMBER

1. They, he or she must be given every opportunity for vindication.
2. They are entitled to (a) copies of the charges against them; (b) names of accusers and witnesses; © a chance to see them and hear their statements; (d) opportunity to present their own witnesses and make their own statement to the church. Jesus Christ Fellowship Community Church body is empowered to exercise discipline (Matt. 18:17; I Cor. 5:4; 2 Cor. 2:6-7; 2 Thess. 3:14-15). Since this important matter of discipline is not committed to leaders only, but to the whole congregation, this will also support the concept of Church polity - congregational government.

Leadership: the whole Jesus Christ Fellowship Community Church family will be involved in choosing leaders as the Word of God and His divine Holy Spirit gives guidance and instructions, (Acts 1:23, 26; 6:3,5; 15:22, 30; 2 Corinthians 8:19).

Ordinances: Will be observed according to the Holy scriptures; Baptism-
Holy Communion by the whole church body (Matthew 28:19-20; I Corinthians 11:17-34)

The Jesus Christ Fellowship Community Church will hold business meetings with the whole church body four (4) times a year at scheduled times agreed by the pastor and congregation.

The Jesus Christ Fellowship Community Church shall be authorized and empowered to pay their pastor reasonable compensation for services rendered according to the Word of God; Scriptural support (I Timothy 5:17-18; 2 Corinthians 9:10-15; Luke 10:7).

Section 2.2 Limitations on Actions no part of the net earnings of the corporation shall inure to the benefit of, or be distributable to any member, director, officer or other private person, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in section 2.1 of this Article. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code of 1986, as amended (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code of 1986, as amended (or the corresponding provision of any future United States Internal Revenue Law).

Section 2.3 Dissolution; upon the dissolution of the corporation or the winding up of its affairs, the Board of Directors shall, after paying or making provision for the payment of all of the liabilities of the corporation, dispose of all of the assets of the corporation exclusively to such charitable; religious, scientific or educational organizations which would then exist and qualify as an exempt organization under section 501 (c) (3) of the Internal Revenue Code of 1986, as amended (or the corresponding provision of any future United States Internal Revenue Law) or if not, to such organization or organizations which are then so qualified as the Board of Directors shall determine. Any such assets not so disposed of shall be disposed of by the circuit court of the county in which the principal office of the corporation is then located, exclusively for the purposes of the corporation or to such organizations which are organized and operated exclusively for such purposes as the court shall determine.

ARTICLE IV
PERIOD OF DURATION

The period of the duration of this corporation is perpetual unless dissolved according to law. This corporation existence shall commence with filing with the Secretary of State.

ARTICLE V

This corporation is original under a non-stock basis.

ARTICLE VI
MANNER OF ELECTION

The manner in which the directors are elected or appointed: the qualification of directors and the manner of their admission and dismissal shall be developed by the Board of Directors, and provided for in the by-laws, which shall govern the internal affairs of this corporation.

ARTICLE VII
INITIAL BOARD OF DIRECTORS

The number constituting the initial Board of Directors, trustees or managers of the corporation is eleven. The initial Board of Directors will serve until the scheduled business meeting. When the whole Jesus Christ Fellowship Community Church body meet and accept the recommendations from the initial Board of Directors to elect if needed Directors in compliance with the Bylaws.
