The undersigned, for the purpose of forming a not for profit corporation under Chapter 617, Florida Statutes, does hereby adopt the following Articles of Incorporation:

#### ARTICLE I: NAME

The name of the corporation is Washington County Humane society Incorporated.

#### ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address of the corporation is 861 Rustin Drive, Chipley, Fl 32428.

#### ARTICLE III: PURPOSE

The purpose of this Corporation is to provide for the care and shelter of animals and maintain a prescribed plan to regulate the population of stray and unwanted animals.

#### ARTICLE IV: QUALIFICATION

The qualifications for members and the manner of their admission are stated in the bylaws of the corporation.

#### ARTICLE V: INITIAL REGISTERED OFFICE AND AGENT

The initial registered office and agent of the corporation is Roy Lake, 1314 Jackson Ave., Chipley, PL 32428.

#### ARTICLE VI: INITIAL BOARD OF DIRECTORS
