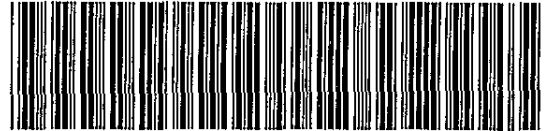

**ARTICLES OF INCORPORATION
OF
SUNSHINE OPEN WRESTLING ASSOCIATION, INC.**

The undersigned, desiring to for a corporation not-for-profit under Chapter 617, Florida Statutes, as amended, hereby executes and adopts the following Articles of Incorporation:

**ARTICLE I
NAME**

The name of the corporations shall be SUNSHINE OPEN WRESTLING ASSOCIATION, INC. Its principal office shall be at 11103 Townsend Lane, Boynton Beach, Florida 33437 or at such other place as may be designated, from time to time, by the Board of Directors.

**ARTICLE II
DURATION**

The period of duration of the Corporation is perpetual.

**ARTICLE III
PURPOSE**

1. The purpose for which the Corporation is organized is to further the interests of the members, including but not limited to, the development and promotion of youth wrestling.
2. To instruct and train individuals for the purpose of improving or developing their capabilities in the sport of wrestling for local, state, national and international competition.
3. To supervise, sponsor and financially assist a disciplined and competitive program of wrestling.

**ARTICLE OF VI
VOTING RIGHTS**

The right to vote on Corporation matters shall be exercised by the Directors as provided in the By-Laws.

**ARTICLE VII
LIABILITY FOR DEBTS**

Neither the officers, nor the directors of the Corporation shall be liable for the debts of the Corporation.

ARTICLE VIII BOARD OF DIRECTORS

Section 1. The number of directors constituting the initial Board of Directors of the Corporation is three (3) and the name of the persons who will serve as the initial Board of Directors of the Corporation are:

Section 2. The Board of Directors shall be the persons who will manage the corporate affairs of the Corporation and are vested with the management authority thereof. The Board of Directors will be responsible for the administration of the Corporation and will have the authority to control the affairs of the Corporations, as are more fully set forth in the By-Laws of the Corporation.

Section 3. The method of election and terms of office, removal and filling of vacancies shall be as set forth in the By-Laws of Corporation.

ARTICLE IX BY-LAWS

The By-Laws of the Corporation may be adopted, amended altered or rescinded as provided therein; provided, however, that at no time shall the By-Laws conflict with these Articles of Incorporation.

ARTICLE X CONSTRUCTION

In the event of any conflict between the terms of the Articles of Incorporation or the By-Laws, the following order of priority shall apply: the Articles of Incorporation and the By-Laws.

ARTICLE XI SOLE INCORPORATOR

The name and address of the sole incorporator is as follows: Gary Townsend, and the street address of the sole incorporator shall be 11103 Townsend Lane, Boynton Beach, FL 33347.

ARTICLE XIII INDEMNIFICATION

The Corporation shall indemnify its directors, officers and committee members and may indemnify its employees, agents and representatives, to the fullest extent permitted by applicable Florida Statutes, as the same may be amended and supplemented, from and against any and all of the expenses or liabilities incurred in defending a civil or criminal proceeding, or other matters referred to in or covered by said provisions, including, but not limited to, the advancement of expenses prior to the final disposition of such proceedings and amounts paid in settlement of such proceedings, and the indemnification provided for herein shall not be deemed exclusive of any other rights to which those indemnified may be entitled under any By-Law, agreement, vote of members or disinterested directors, officers, or otherwise, both as to action in his or her official capacity and as to action in another capacity while holding such office, and shall continue as to a person who has ceased to be a director, officer, committee member, employee or agent, and shall inure to the benefit of the heirs, executors and administrators of such a person and an adjudication of liability shall not affect the right to indemnification for those indemnified. The foregoing right of indemnification shall be in addition to and not exclusive of all other rights to which such officer, director or committee member of the Corporation may be entitled.

ARTICLE XIII OFFICERS

The affairs of the Corporation shall be managed by a President, Vice-President, Secretary and a Treasurer, and if elected by the Board of Directors, and any such other officers and assistant officers as may be designated by the Board of Directors. The Board of Directors at each annual meeting shall elect to serve for a term of one (1) year, a President, a Vice-President, a Secretary and a Treasurer, and such other officers as the Board of Directors may from time to time determine appropriate. 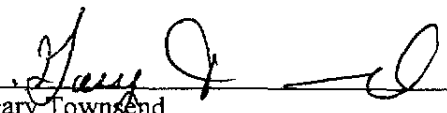

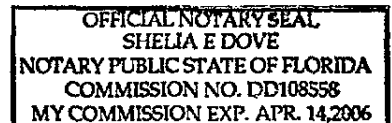

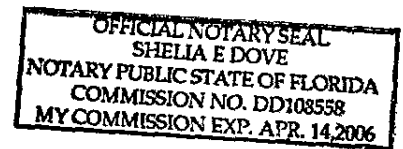
