NAME:

ARTICLE III **PURPOSE:**

The purpose for which the corporation is organized is exclusively for the purpose of charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under 501 (C) (3) of the Internal revenue Code, or the corresponding section of any future tax code.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from the federal income tax under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c) (2) of the Internal Revenue Code or the corresponding section of any future federal tax code.

ARTICLE VI **DISSOLUTION:**

Upon dissolution of the corporation, assets be distributed of one or more exempt purposes within the meaning of section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code, or shall distributed to the federal government, for a public purpose.
