

The undersigned, BUDDY PRESSLEY, acting as incorporator of a corporation pursuant to chapter 617, Florida Statutes, does hereby execute the following Articles of Incorporation:

1. The name of the corporation shall be:

2. The specific purpose for which the corporation is initially organized is to promote and market the international summer camp experience for high school youth and all other business for which corporations may be incorporated.
