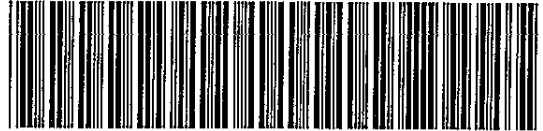

ARTICLES OF INCORPORATION

The undersigned, acting as incorporators of a corporation pursuant to Chapter 617 of the Florida Statutes adopt the following Articles of Incorporation.

ARTICLE I NAME
