ARTICLES OF INCORPORATION OF

SECRETARY OF STATE ALLAHASSEE, FLORIDA JACKSONVILLE WAVES BASEBALL CL

In accordance with Chapter 617, F.S., (Not for Profit)

ARTICLE I

The name of this corporation is: Jacksonville Waves Baseball Club, Inc.
