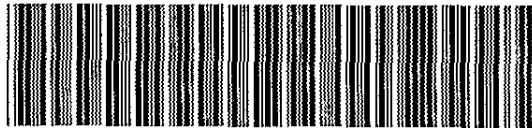

ARTICLES OF INCORPORATION
OF
JACKSONVILLE WAVES BASEBALL CLUB, INC.

In accordance with Chapter 617, F.S., (Not for Profit)

ARTICLE I

The name of this corporation is: Jacksonville Waves Baseball Club, Inc.

ARTICLE II

The principal place of business and mailing address of this corporation shall be :

ARTICLE III

The corporation is a not for profit corporation. The purpose(s) for which the corporation is organized are :

(A) The specific and primary purposes for which this corporation is formed are to operate for the advancement of charity and education and for other charitable purposes, by the distribution and expenditure of its funds for those purposes, and particularly for youth baseball assisting children in becoming team players, learning sportsmanship, to improve their health and to learn a skill.

(B) The general purposes for which this corporation is formed are to operate exclusively for charitable and educational purposes which will qualify it as an exempt organization under 26 U.S.C.A. § 501 (c)(3), or corresponding provisions of any subsequent federal tax laws, including, the development of children through youth baseball.

(C) This corporation shall not, as a substantial part of its activities, carry on propaganda or otherwise attempt to influence legislation; nor shall it participate or intervene (by publication) or distribution of any statements or otherwise in any political campaign on behalf of any candidate for public office.

ARTICLE IV

The manner for which the directors are elected or appointed:

The directors shall be initially appointed and annually thereafter elected as set forth in the corporate by-laws.

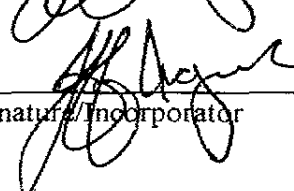
