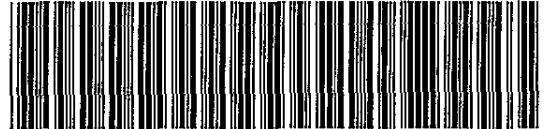

**ARTICLE I.**

To teach and keep the seven Unities of the body, to restore the faith, love, and joy in the heart of all mankind, to teach character building, moral values, pride in home/community, self-development, educational, and career development to those individuals who need further training in social and personal competencies that will help them to master their life skills development to deal more effectively with everyday situations and life events, and other programs to aid those in need.

**ARTICLE III.**

The duration of this corporation shall be perpetual, no stock and shall have no members

**ARTICLE IV.**

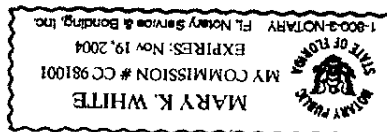
