

## PLAN OF MERGER

## JASMINE POINTE AT CARLTON LAKES, INC. JASMINE PONTE II AT CARLTON LAKES, INC. JASMINE POINTE III AT CARLTON LAKES, INC. JASMINE POINTE AT CARLTON LAKES COMMONS, INC.

WHEREAS, Jasmine Pointe at Carlton Lakes, Inc., a Florida not-for-profit Corporation, is the corporate entity responsible for the operation and management of the condominium known as Jasmine Pointe I at Carlton Lakes, a Condominium, as more particularly described in the Declaration of Condominium thereof, originally recorded at O.R. Book 3628, Page 3742, et. seq., of the Public Records of Collier County, Florida, and as amended; and

WHEREAS, Jasmine Pointe II at Carlton Lakes, Inc., a Florida not-for-profit Corporation, is the corporate entity responsible for the operation and management of the condominium known as Jasmine Pointe II at Carlton Lakes, a Condominium, as more particularly described in the Declaration of Condominium thereof, recorded at O.R. Book 3614, Page 962, et. seq., of the Public Records of Collier County, Florida, and as amended; and

WHEREAS, Jasmine Pointe III at Carlton Lakes, Inc., a Florida not-for-profit Corporation, is the corporate entity responsible for the operation and management of the condominium known as Jasmine Pointe III at Carlton Lakes, a Condominium, as more particularly described in the Declaration of Condominium thereof, recorded at O.R. Book 3636, Page 2008, et. seq., of the Public Records of Collier County, Florida, and as amended; and

WHEREAS, Jasmine Pointe at Carlton Lakes Commons, Inc., a Florida not-for-profit Corporation, is the corporate entity responsible for the operation and management of the recreational facilities and other common facilities within the Jasmine Pointe Complex as more particularly described in the Declaration of Covenants thereof, recorded at O.R. Book 3614, Page 916, et. seq., of the Public Records of Collier County, Florida, and as amended; and

WHEREAS, the Boards of Directors of all of the four above-named corporations have met and determined that simplicity and economy of operation of the three Condominiums and the Commons will be enhanced by the merger of the aforementioned corporations into a single operating entity.

THEREFORE BE IT RESOLVED that pursuant to Section 617.1101 to 617.1103, Florida Statutes, the following plan of merger is hereby adopted.

1. Jasmine Pointe II at Carlton Lakes, Inc., a Florida not-for-profit corporation; Jasmine Pointe III at Carlton Lakes, Inc., a Florida not-for-profit corporation; and Jasmine Pointe at Carlton Lakes Commons, Inc., a Florida not-for-profit corporation; shall be the merging corporations, and Jasmine Pointe at Carlton Lakes, Inc., a Florida not-for-profit corporation, shall be the surviving corporation.

- 2. Subsequent to the merger, Jasmine Pointe II at Carlton Lakes, Inc., Jasmine Pointe III at Carlton Lakes, Inc., and Jasmine Pointe at Carlton Lakes Commons, Inc. will be subject to the Articles of Incorporation and By-Laws of Jasmine Pointe at Carlton Lakes, Inc., as amended.
- 3. Jasmine Pointe at Carlton Lakes, Inc. shall, upon the merger, assume all the powers, rights, duties, assets and liabilities of Jasmine Pointe II at Carlton Lakes, Inc., Jasmine Pointe III at Carlton Lakes, Inc., and Jasmine Pointe at Carlton Lakes Commons, Inc.
- 4. The adoption of this plan of merger shall not be construed as a consolidation of the three Condominiums and the Commons operated by the merging corporations.
- 5. This Plan of Merger shall become effective upon the approval of the Boards of Directors and membership of each merging corporation, pursuant to Section 617.1103, Florida Statutes, and the filing of Articles of Merger with the Department of State pursuant to Section 617.1105, Florida Statutes.
