

Articles of Amendment of

Christian Financial Services Ministries, Incorporated (Document #: N03000003828)

Pursuant to the provisions of Florida Statutes sections 617.1001 et. seq., the undersigned Florida nonprofit corporation adopts the following Articles of Amendment to its Articles of Incorporation.

The name of the corporation is CHRISTIAN FINANCIAL SERVICES MINISTRIES, INCORPORATED.

FIRST: Article III is amended as follows:

The corporation is organized exclusively for religious, charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 (or corresponding provision of any future United States Internal Revenue law), including, but not limited to, for such purposes, the providing of Bible-based accounting and financial planning services, financial counseling services, and financial educational services to churches, parachurch organizations, and Christians, all from the Christian perspective that the Bible is the infallible Word of God.

No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its directors, officers, employees, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the tax-exempt purposes of the corporation.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, except that the corporation shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law) or by an organization, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).
