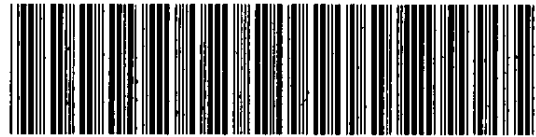



SECOND: The articles of incorporation were filed on **MAY 6, 2003.**


THIRD: The corporation has not commenced to conduct its affairs.
