In Compliance with Chapter 617, F. S. (Not for Profit)

### ARTICLE I NAME

### ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

The purposes for which this organization is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of section 501C(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue law.

Notwithstanding any other provision of these articles, this organization shall not carry on any other activities not permitted to be carried on by an organization exempt from the federal income tax under section 501C(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue law.

In accordance with the above paragraphs the general purpose and objective of this church corporation shall be to provide an appropriate and necessary legal entity to carry out the mission and program of Mt. Olive Baptist Church.

Said corporation is to have the power to do any and all things necessary or expedient for carrying out the said objective and purpose of the corporation and in general to possess all rights, privileges and immunities, and enjoy all the benefits granted to corporations of similar character under the laws of the State of Florida.

### ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed:

All members of Mt. Olive Baptist Church shall be members of this corporation. Qualification and membership of Mt. Olive Baptist Church shall be as provided in the Church Constitution and Bylaws. The Board of Directors of this corporation shall be the elected deacons of the church plus the pastor. Deacons shall be elected as provided in the Church Constitution and Bylaws.

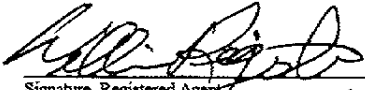

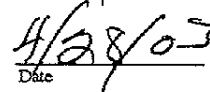
