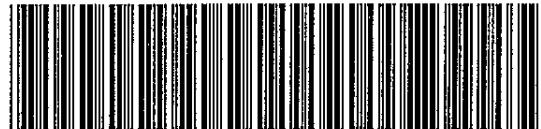

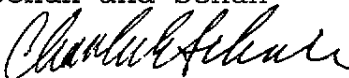

ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of this corporation is True Holiness Church of God,
Inc.

ARTICLE II - DURATION

This corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

This corporation is organized as a not for profit corporation to function as a church for religious, charitable, and educational purposes for adults and children, and for the purpose of transacting any or all lawful business as a corporation not for profit incorporated under Florida law. No part of the assets or net earnings shall inure to the benefit of the directors or officers or any private individual, and no substantial part of the activities of the corporation shall involve carrying on propaganda or otherwise attempting to influence legislation or intervene in (including the publication or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

ARTICLE IV - NONSTOCK ORGANIZATION

This corporation shall not issue shares of stock but membership may be evidenced by a certificate of membership which shall contain a statement prominently upon the face of the

certificate that the corporation is a nonprofit corporation. No dividends shall be paid.

ARTICLE V - PRINCIPAL OFFICE, INITIAL REGISTERED OFFICE AND AGENT

The principal office, street and mailing address, and the initial registered office of this corporation is: 1900 13th St. S., St. Petersburg, Fla. 33705, and the name of the initial registered agent of this corporation at that address is: Perlana Worlds.

ARTICLE VI - INCORPORATOR

The name and address of the incorporator of this corporation is:

Perlana Worlds, 2633 19th St. S., St. Petersburg, Fla. 33705.

ARTICLE VII - BYLAWS

The power to adopt, alter, amend or repeal Bylaws shall be vested in the board of Directors as more specifically set forth in the Bylaws.

ARTICLE VIII - BOARD OF DIRECTORS

All corporate powers shall be exercised by or under the authority of, and the business and affairs of this corporation shall be managed under the direction of the Board of Directors of this corporation. The election or appointment of the Board of Directors shall be as stated in the Bylaws.

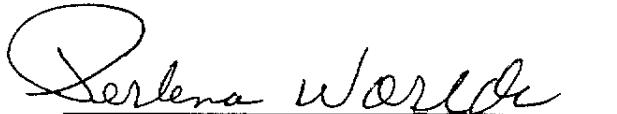
ARTICLE IX - AMENDMENT TO CHARTER

ARTICLE X - DISSOLUTION OF CORPORATION

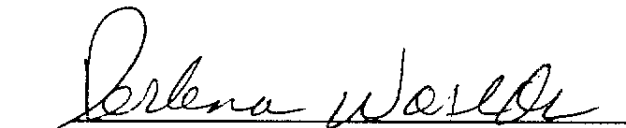
