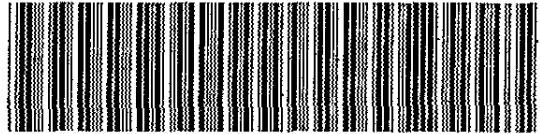

In compliance with the requirements of F.S. chapter 617, the undersigned hereby act as incorporators in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I – NAME**

The name of this corporation is Getting Free, Inc.

**ARTICLE II – PRINCIPLE OFFICE**

The street address of the principal place of business is 512 Hibiscus Drive, Deerfield Beach, FL 33442; the mailing address is P.O. Box 8732, Deerfield Beach, FL 33443

**ARTICLE III – PURPOSE**

The purpose for with the corporation is organized..exclusively for conferences in ministry, charitable, educational, religious or scientific purposes, additionally to spread the Word of God and minister to the Spiritual needs of the community; within the meaning of section 501©(3) of the Internal Revenue Code (or corresponding section of any future Federal tax code).

No part of the net earnings of our corporation shall inure to the benefit of, or be distributable to its members, trustees, directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of Section 501©(3) purposes. No substantial part of the activities of the corporation shall be the carrying on of propaganda; or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on:

(a) by a corporation exempt from Federal income tax under Section 501 (c)(3) of the Internal Revenue Code (or corresponding section of any future federal tax code) or (b) by a corporation, contributions to which are deductible under Section 170(c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax code). This Corporation shall be a non-stock corporation.

**ARTICLE IV – DIRECTORS ELECTED/APPOINTED**

The membership of this Corporation shall initially be appointed. New members may be admitted only by the affirmative vote of at least two-thirds of the then members.
